

### What is Anemila? What benefits does it have?

Anemila is a treatment-supporting additive used in anemia caused by many factors. Thanks to the rich plant extracts, vitamins and provitamins in its content;

- Grape Seed Extract (Grape Seed and Grape Skin Extract) Black grape seed is an antioxidant. It protects the animal body from internal and external free oxygen radicals. It strengthens and protects blood vessels and helps in the treatment of vascular diseases.
- √ It regulates blood and lymph circulation, prevents anemia thanks to its blood-forming feature, and cleans the blood. It is good for skin diseases and also increases the effect of Vitamin C.
- ✓ Beta Vulgaris (Red Beet) is rich in vitamins A-B-C-P and minerals, it has a protective effect on internal organs and supports the prevention of chronic diseases such as cardiovascular diseases. It helps to clean the blood and detoxify the liver. It expands the vessels and facilitates blood circulation.
- √ It supports bone marrow and spleen functions thanks to its B12, K3, H2 and organic iron content and powerful vitamins and provitamins.



#### What is anemia? How does it occur?

Anemia may present as a decrease in the number of red blood cells in the blood, their inability to produce them, or an increase in their destruction. The causes of anemia can be grouped under two main headings as rapid destruction and slowed production of erythrocytes. If the substances necessary for the production of erythrocytes are not found in the blood, there will be no production. For the globin of hemoglobin, its precursors, proteins necessary for the red blood cells' own structures, or precursors must be present in the blood. Iron is needed in the blood for hemoglobin synthesis.

Depending on these, the causes of anemia are;

- Anemia can be caused by health problems that cause blood loss, a decrease in red blood cells. This process is interrupted in sick or injured cats and dogs and anemia can result from a number of diseases and injuries, including:
- √ Hypothyroidism
- √ Parasite infestation that causes blood loss (hookworms, roundworms, fleas, ticks, etc.)
- Cancer can cause a variety of secondary problems, including anemia.
- Anemia due to malnutrition
- Mechanical trauma, postpartum indications,
- √ Some dogs and cats or breeds are predisposed to diseases or conditions known to cause anemia.
- ✓ Infectious diseases (mostly anemia, tick-borne infestations)
- Autoimmune diseases force body systems to destroy their own red blood cells.
- Medications non-steroidal anti-inflammatory drugs that often cause bleeding in the gastrointestinal tract.
- √ Poisoning of the cat or dog with toxic substances or heavy metals.
- Chronic diseases (especially old dogs, kidney failure and oncological treatment etc.)

## Symptoms of anemia;

- Tiredness; during play or exercise easily run out of energy
- Dark blood in stool or vomit
- ✓ Pale gums
- ✓ Anorexia weight loss
- Pallor in eyes
- ✓ Discoloration of the skin or mucous membranes
